Agreement between user and 123 Learn Curriculum

With respect to your access and use of the 123 Learn Curriculum, 123 Learn Curriculum, provides its services to you, subject to the following Terms of Use (TOU), which may be updated from time to time by 123 Learn Curriculum without notice to you. By using the 123 Learn Curriculum web site, you signify your agreement to this Terms of Use.

Licensing: Your subscription to any of the 123 Learn Curriculum does not constitute the purchase of the materials on the site. Your subscription constitutes a license to use the materials on the 123 Learn Curriculum site as long as the subscription is in effect. If for any reason the subscription is terminated, you may no longer use these materials, as the license to use the materials is no longer in effect.
